

PRODUCT WARRANTY CARD

LC BREEZE 48100

1) Consumer Rights

- a) When purchasing the product from an authorized reseller within the European Union, consumer law regulations apply. The product is covered by warranties that cannot be excluded under the Consumer Law of the respective Territory.
- b) The benefits provided under this Warranty are in addition to all other rights and legal remedies related to the Product that the User is entitled to under Consumer Law or any other law that cannot be excluded.

2) General Warranty Provisions

- a) Under this warranty for LC Breeze products (hereinafter referred to as the "Product"), Breeze Energies Sp. z o.o. provides a warranty covering manufacturing and material defects;
- b) The Product is covered by this limited warranty for a period of 10 years. The warranty period begins on the date of sale or within six months from the date of shipment from the Breeze Energies Sp. z o.o. facility, whichever occurs first;
- c) The remaining usable capacity of the LC Breeze energy storage system is 60% at the earlier of the following: the end of the warranty period or the achievement of a total energy throughput of 6 MWh per kWh of usable battery capacity, determined as the integral of the absolute value of power at the DC terminals of the energy storage system.

3) Warranty Conditions

- a) Niniejsza gwarancja przysługuje nabywcy, który zakupił Produkt od firmy Breeze Energies lub autoryzowanego sprzedawcy Breeze Energies w celu użytku na kontynencie, na którym firma Breeze Energies dokonała pierwotnej sprzedaży, zgodnie z zamierzonym przeznaczeniem i pod warunkiem wykonania instalacji oraz użytkowania Produktu zgodnie z obowiązującymi przepisami w kraju instalacji;
- b) This warranty covers only the repair or replacement of a defective Product. Breeze Energies will repair or replace the Product if it is found to be defective and has been returned within the warranty period. The repaired or replaced Product will continue under the original warranty period that has not yet expired. In either case, this does not warrant an extension of the warranty period;

- c) This warranty applies to the Product when used, installed, and operated in accordance with the Product documentation.;
- d) The purchaser has the right to transfer the warranty to any beneficiary, in which case the warranty remains valid for the remaining period under the terms of the limited warranty, provided that the Product is not relocated from its original installation site or dismantled and subsequently reinstalled after the initial installation;
- e) **Any work related to relocating the Product from its original installation site must be preceded by obtaining written consent from the manufacturer. Failure to obtain written consent before the relocation will result in the immediate loss of the warranty.;**
- f) The Product must be installed in enclosed spaces..

4) Warranty Exclusions

To the extent permitted by law, Breeze Energies Sp. z o.o. excludes all liability for the Product insofar as any damages or defects have been caused by or have contributed to the following reasons:

- a) Failure of the inverter or batteries;
- b) Mechanical damage caused by installation or use not in accordance with the Product user manual;
- c) Exceeding the electrical operating parameters specified in the Product datasheet;
- d) Improper electrical connection of the Product;
- e) Mishandling, negligence, or any other improper or incorrect treatment of the Product not in accordance with the Product user manual;
- f) Transportation, including but not limited to dropping, stepping on, deforming, or striking the Product;
- g) Storage, installation, commissioning, modifications, or repairs of the Product performed contrary to the Product user manual;
- h) Any modifications or attempts to extend or shorten the Product's lifespan;
- i) Removal or damage to warranty seals;
- j) Removal and reinstallation in a location other than the original installation site without written confirmation from Breeze Energies;
- k) Exposure to water, conductive dust, or corrosive gases;
- l) Connecting the Product with different types of battery modules or a battery not supplied by Breeze Energies;
- m) Installation or maintenance of the Product not in accordance with the Product user manual
- n) Normalne zużycie,
- o) Normal wear and tear, damage, surface defects, dents, or marks that do not affect the Product's operation;
- p) Theft or vandalism affecting the Product or any of its components;

5) Transportation Costs

If the product needs to be sent to the service center under warranty, the transportation costs shall be covered by the customer. If the defect is recognized as covered under warranty, the manufacturer commits to reimbursing the transportation costs.

6) Dispute Resolution

In the event of a dispute regarding the warranty, the parties agree to attempt to resolve the issue through negotiation. If no agreement is reached, disputes shall be settled in accordance with the applicable law within the jurisdiction of the manufacturer.

7) Final Provisions

If any provision of this document is unenforceable, unlawful, or invalid, rendering this document or any part of it unenforceable, unlawful, or invalid, that provision shall be removed, and the remainder of the document shall remain in effect.

If any provision of this document is unenforceable, unlawful, or invalid in one jurisdiction but not in another, rendering this document or any part of it unenforceable, unlawful, or invalid in one jurisdiction but not in another, that provision shall be removed only in the jurisdiction where it is deemed unenforceable, unlawful, or invalid.
